Terms & Conditions

1. ORGANISING COMPANY AND AIM OF THE PROMOTION

The organiser of the promotion is Consejo Regulador de la Denominación de Origen Protegida Cava (hereinafter "the D.O. Cava"), with a registered office in the Avenue Tarragona number 24, Vilafranca del Penedès, Barcelona (Spain), with NIF: Q0871003J. The D.O. Dates:

Handover of prizes
